Decision concerning the sixteenth instalment of “E3” claims taken by the Governing Council of the United Nations Compensation Commission at its 113th meeting, held on 13 December 2001

The Governing Council,

Having received, in accordance with article 38 of the Provisional Rules for Claims Procedure (“the Rules”), the report and recommendations made by the panel of Commissioners concerning the sixteenth instalment of “E3” claims, covering 17 claims, 1/

1. Approves the recommendations made by the panel of Commissioners, and, accordingly,
2. Decides, pursuant to article 40 of the Rules, to approve the amounts of the recommended awards concerning the claims covered in the report. The aggregate amounts per country, based on the recommendations contained in table 57 of the report, are as follows:

3. Reaffirms that when funds become available payments shall be made in accordance with decision 100 (S/AC.26/Dec.100 (2000)),

4. Recalls that when payments are made in accordance with decision 100, and pursuant to the terms of decision 18 (S/AC.26/Dec.18 (1994)), Governments shall distribute amounts received to the designated claimants in respect of approved awards within six months of receiving payment, and shall, not later than three months after the expiration of this time limit, provide information on such distribution,

5. Takes note of the withdrawal of a portion (concerning contract losses with Kuwaiti party for which no compensation was recommended by the Panel) of the claim submitted by the Government of India, the request for which was received after the Panel signed and submitted its report and recommendations to the Governing Council,

6. Requests the Executive Secretary to provide a copy of the report to the Secretary-General, to the Government of the Republic of Iraq and to each respective Government.
